Superintendent Chord updated the board on the October financials. He reported that the Maintenance technician position has been posted on the district website and in the Islands' Sounder. President Zoeller will report on the Capital Needs Assessment in the December Special Board Meeting.

Superintendent Chord provided an update on the Operations Committee. The ultrasound machine will be delivered to the clinic on November 16, the front desk position remains open. Island Primary Care – Orcas had a consultant present on efficiency of clinic visits which was well received by the staff. The availability of OB visits will increase from 2- 4 days per month and the cardiology telehealth program is going very well.

He also updated the board on the Quality, Medical Director and EMS/After-Hours committees.

a. **DOH Oral Health Grant**

A retired dentist, Dr. Ehlens, has agreed to help with dental services. Planning meetings continue.

b. Other Items:

Cash reserves have been invested and the January 8 Board Retreat planning is ongoing.

The newly elected board members will be sworn in within 10 days of the election certification. The board will need to identify who will fill the vacant committee seats of outgoing board members.
