### **AUDIT RESULTS**

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of Orcas Island Health Care District from January 1, 2019 through December 31, 2020.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2020 and 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable general disbursements
- Self- insurance for Paid Family and Medical Leave
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

#### INFORMATION ABOUT THE DISTRICT

The San Juan County Public Hospital District No. 3, doing business as Orcas Island Health Care District (OIHCD), was formed by a special election of Orcas Island citizens in April 2018. At the same time, residents elected five Commissioners to govern the District all of whom were sworn in on May 8, 2018. The Commissioners have gone through two elections since, 2019 and 2021, and the six-year terms are staggered to ensure consistency in the Board.

Following several years of working with the existing primary care clinics, UW Medicine and Orcas Family Health Center, the OIHCD entered into a new Clinical Services Agreement with Island Hospital. Coinciding with the change in operators, the two clinics were consolidated into a single entity, now known as Island Primary Care – Orcas. The Clinical Service Agreement (CSA) with Island Hospital runs from April 1, 2021 through March 30, 2026. The OIHCD owns the medical clinic building and equipment. When the CSA was signed it included a Lease Agreement with Island Hospital to run concurrent with the CSA.

The District currently has one employee who serves in a largely administrative capacity. All of the Districts' revenues are generated by property tax proceeds. For the 2019 and 2020 calendar years, total expenditures were approximately \$852,498 and \$1,171,679, respectively
